FREQUENTLY ASKED QUESTIONS (FAQ)

1. Question: Who is the developer of WAZSHOLLY GARDEN PHASE 2?

Answer: WAZSHOLLY GARDEN PHASE 2 is being developed by WAZSHOLLY PROPERTIES LIMITED, a

registered company in Nigeria.

2. Question: Where exactly is WAZSHOLLY GARDEN

PHASE 2

Answer: WAZSHOLLY GARDEN PHASE is at behind

Area J Police Command, Elemoro, Ibeju-Lekki

2. Question: How much is the land?

Answer: Land is currently ₹35,000,000 for a plot of 500sqms (Outright payment and 3 months)

3. Question: What is the title on WAZSHOLLY GARDEN PHASE 2?

Answer: The estate has a Governor's consent, Deed of Assignment and Gazette. It is free from all encumbrances of the local community (Omonile).

4. Question: Would there be any survey/documentation fee?
